7.4. NETWORK SWITCH UPGRADE

7.6. ADDITIONAL ALCOHOLIC BEVERAGE LICENSE RENEWALS 2021

In order to renew an alcoholic beverage license, an application must be submitted for review by the Police Department and inspections are done by the Building Official and Fire Marshal. 7.8. ACCEPT REVISED CDBG-NDR TIMELINE FOR 1-YEAR EXTENSION

January, 2020 with the statutory deadline for the CDBG-NDR grant set at September 30, 2022 requiring that all grant funds be spent, the City established a timeline with performance and action deadline benchmarks to be followed to assure that all the CDBG-NDR funds were spent by the deadline. During the recent closing session of the Congress a statutory amendment was approved extending the deadline to September 30, 2023.

It is recommended the City Council accept the revised CDBG-NDR Grant timeline with benchmarks based on 1-year extension of spend deadline to September 30, 2023.

8. ACTION ITEMS

8.1. PUBLIC HEARING: RENAISSANCE ZONE CASE NO. M-96, CONDITIONAL APPROVAL, DAKOTA APPLE PARTNERSHIP

At its meeting of December 17, 2020, the Renaissance Zone Review Board reviewed an application for Project M-96, filed by Chad Thompson of Dakota Apple Partnership for a new construction project on a multi-tenant retail store. Dakota Apple Partnership is requesting a five-year property tax exemption, including improvements on property located at 304 4th Avenue NW.

The Renaissance Zone Review Board recommends conditional approval of Renaissance Zone application M-96 for a five-year property tax exemption, including improvements on the property located at 304 4th Avenue NW.

8.2. NO PARKING ON 10TH STREET NE AT 9TH AVENUE NE

The Engineering Department was contacted by the Minot Public Schools Transportation Services about school buses having difficulty navigating an eastbound 9th Avenue NE right-turn movement to head southbound on 10th Street NE.

Both 10th Street NE and 9th Avenue NE in this vicinity are 24-foot wide roadways that currently have one side of the road designated as 'no-parking.' It is the Engineering Department's, as well as Minot Public Schools Transportation Services, feeling that if a short no-parking zone was created on east side of 10th Street NE immediately south of 9th Avenue NE that school buses, along with city maintenance and emergency services vehicles, would be better able to navigate this intersection.

It is recommended that Council pass a resolution to add a parking restriction to the following location:

1. East side of 10th Street NE, south 50-feet from the center of the 9th Avenue NE intersection.
