Special Conditions

- 1. The then U.S. Department of Defense Office of Economic Adjustment Grant Program-Specific Terms and Conditions effective November 2, 2017, for Community Investment (Construction Grants) are applicable to this award except sections I.F., and I.L.(1) thru I.L.(4), or as noted below.
- 2. This grant period is from September 1, 2021, through September 30, 2025. Eligible costs incurred between September 1, 2021 and the date of this agreement are allowable and reimbursable.
- 3. Prior to the disbursement of funds for sub-recipient activities under this award, the Grantee shall submit an executed agreement(s) for these activities with each sub-recipient.
- 4. Pre-award costs in the amount of \$1,431,402 for planning, engineering and design expenditures incurred during the period of September 1, 2018, through August 31, 2021, as reflected in the application are approved.
- 5. Prior to the disbursement of funds under this award, Grantee must provide for the Grantor's acceptance: 1) evidence of the availability of the non-Federal share for the completion of the project; 2) site control documentation; and, 3) evidence of a performance or surety bond sufficient for the completion of the project.
- 6. Grantee shall ensure requests for disbursements under this award are in proportion to the Federal and non-Federal portions of the total approved project costs. For example, for every \$1 in eligible costs on a project with a 50% Federal contribution, requests for disbursements should ensure Federal funds do not exceed 50% of the expenditures for the project at any point over the term of the award.
- 7. As of the date of this Notice of Award, the Grantor has not satisfied the requirements of the National Environmental Policy Act and the Grantee has not completed all permitting required for the project to proceed. The Grantee shall not proceed with construction nor undertake any ground-disturbing activities without prior approval from the Grantor indicating compliance with the National Environmental Policy Act and any other environmental requirements, and Grantor acceptance the Grantee has secured the necessary permits to undertake the project. This restriction does not apply to project design, development of environmental information, administrative activities, securing permits, or other activities that present no risk of irreparable injury to the environment.
- 8. In the event the final project cost is less than the estimated total project cost, both the Federal award and local match shall be proportionally reduced based on the ratio of Federal and local match funds in the original award.
- 9. Project Development Schedule:

Design Complete: December 31, 2021 Construction Start: May 1, 2022 Construction Complete: July 31, 2025

Failure to meet this Project Development Schedule is considered a violation of the Grant Agreement and may result in action by the Grantor to suspend and/or terminate the grant. The Project Development Schedule may only be revised through prior approval by the Grantor.
