5.7. 4577 – BEL AIR ELEMENTARY SCHOOL SAFE ROUTES TO SCHOOL – TRANSPORTATION ALTERNATIVES GRANT AWARD

In December 2020, and with approval by the City Council, the City of Minot applied for Transportation Alternative funds to provide safe routes to Bel Air elementary by constructing a critical hillside pedestrian pathway along 25th Street NW and 10th Avenue NW. Transportation Alternative funds for Fiscal Year 2023 were awarded to the City of Minot on May 4, 2021 with a maximum amount of \$290,000 representing up to 80.93% of the total estimated construction cost to the project to construct the safe route sidewalks. The NDDOT needs confirmation from the City by June 30, 2021 that the city will accept the funds and proceed with the safe routes to school project.

The Minot Fire Department is dependent on radio communication from Minot Central Dispatch. The radio console recently malfunctioned leaving dispatch and the fire department to find a quick fix. 5.11. BUDGET AMENDMENT TO INCREASE AIRPORT EXPENSES FOR THE PURCHASE OF PARKING EQUIPMENT FOR THE NEW PARKING FACILITIES MANAGEMENT

The current parking and revenue control system (PARCS) has exceeded its useful life. As part of the recently awarded parking management agreement, new equipment will be procured to improve the PARCS as well as the customer experience. 5.27. RESOLUTION BETWEEN MOT AND MFD TO PROVIDE ARFF SERVICES

The Minot Fire Department has been providing ARFF services to the Minot airport to ensure compliance with FAA regulations. The Minot Airport has budgeted for three fire personnel, training, maintenance and foam. This way of budgeting has become problematic over the years with the amount of turnover which has resulted in the airport not being charged for a firefighter as it was tied to the person and not the position. The Fire Chief and Airport Director worked with finance and City Attorney to develop this agreement to create a service agreement to provide a base fee for the airport ARFF services. This will clean up the budget for both the airport and fire department.

The Fire Chief requests that council approves and allow the Mayor to sign the Resolution between the Minot Airport and the Minot Fire Department memorializing the agreement in providing Aircraft Rescue and Firefighting (ARFF) services.

5.29. ARTS AGENCY DESIGNATION RESOLUTION

Minot Area Council of the Arts has a goal of being able to regularly offer grants to the Minot arts community. There are annual grant opportunities through agencies such as the National Endowment for the Arts (NEA) for the purpose of regranting, but they are only eligible to apply for these grants with a Local Arts Agency designation. The North Dakota Council on the Arts (NDCA) is receiving ARP funds and they will need assistance in distributing those funds to the artists and organizations who need them. In order to assist with this distribution, NDCA has asked the Minot Area Council of the Arts, as well as The Arts Partnership in Fargo, to pursue an LAA designation, which is necessary to distribute these federal funds.
