We informed the campground of our dogs and that we had 6 dogs, because some campgrounds do limit the number of dogs you can have. We were not informed or aware of any city limits ordinances so we decided that the KOA campground was the best fit for us because it is so close to her work and will be open until November when we will move on to her next assignment wherever it may be. If we had known there was an ordinance we would have looked elsewhere first or did paperwork to get permit sooner. We do like the campground where we are at and would very much like to stay here, the staff have been excellent to us has approved us to stay here with our 6 dogs as you can see with the letter they wrote. We take very good care of our dogs and have been visited by both ACO officers and several of the KOA staff here and have had no issues with anyone. I do my best to keep barking down to a minimum to keep from disturbing any neighbors and keep the area clean primarily for ourselves but also according to park rules. Upon approval of this permit I will get them licensed for the city of Minot. I do not wish to go against any city ordinance ordinance or park policy and hope this permit will be approved so that we do not have to move to another park, if there is one available and open until November or leave the area before my wife's contract ends.
