SUBJECT: RIGHT OF WAY ENCROACHMENT APPLICATION -

ROOFTOP INGRESS/EGRESS STAIRCASE - 220 SOUTH BROADWAY

I. RECOMMENDED ACTION

1. Recommend approval of the Right of Way Encroachment Agreement Application submitted by Derf, Inc. for the installation of a staircase at their building at 220 South Broadway.

III. DESCRIPTION

A. Background

Derf, Inc. wishes to install a staircase along the outside of the southern wall of their building at 220 South Broadway. The bottom of the support beams at the lowest portion of the staircase is a minimum of eight (8) feet above the elevation of the existing sidewalk below.

B. Proposed Project

The proposal is to construct a staircase with necessary landing areas to allow ingress/egress to the rooftop seating area on top of the building. as shown in the attached sketch. The proposed staircase will encroach on the City's right-of-way.

Encroachments within the right-of-way are interpreted as a permanent encroachment as defined in Article I. Section 28-3 of the Code of Ordinances. If the City Council deems that the request is warranted, it should be approved with the following recommendations:

- 1. That the City Council approves the encroachment listed above.
- 2. That the permit holder agrees that the costs of maintenance and replacement be their responsibility.
- 3. That the City Attorney prepares the encroachment permit agreement, including language to protect the City from liability.
- 4. That the City Council retains the right to revoke the encroachment permit if it becomes necessary for any reasons.
- 5. That the permit holder pays a \$100 permit fee.
- 7. That no person may install the proposed staircase within the public right-of-way without having first obtained a permit from the City Engineer.
