SUBJECT: NEW LANDFILL INVESTIGATION (PROJECT NUMBER 4545)

I. RECOMMENDED ACTION

1. Recommend council authorize the Mayor to sign the task order for the New Landfill Investigation with CPS, Ltd.

III. DESCRIPTION

A. Background

In September of 2017, the City of Minot purchased two quarters of land to expand the landfill. Rezoning this land to Public for future landfill use came against significant public opposition. After over a year of public meetings, focus group discussions, site suitability analysis and relocation cost analysis a smaller expansion was eventually rezoned and approved for expansion. The approved expansion will provide about 15-20 years of additional capacity. It was the desire of City Council at that time to begin finding a site for a new landfill.

B. Proposed Project

A site selection study was conducted as part of the focus group and public meeting process. The study identified sites within 20 miles of Minot that could be suitable for a landfill. This task order will utilize that study information to begin talking with landowners about selling land and conducting due diligence on that land prior to purchase. This would include but not be limited to, site suitability, meeting with zoning jurisdiction, acquisition assistance and eventually submitting a preapplication to NDDEQ.

C. Consultant Selection

CPS was selected to provide general solid waste consulting services as part of a Master Services Agreement. They have provided much of the data thus far and have vast amounts of knowledge regarding this project

IV. IMPACT:

A. Strategic Impact:

Landfill siting can be a contentious topic and beginning this work now will ensure we are well prepared for the future when the current landfill nears capacity.

The task order is billed at an hourly basis not to exceed a total of \$350,000. This amount should be sufficient to take a site through a preapplication. If a site fails along the process a different site may need to be selected. Depending on issues that arise, a subsequent contract amendment may be needed.
